6. ACCIDENTAL RELEASE MEASURES

Procedures for cleaning up spills or leaks: Ventilate area. Remove sources of ignition. Prevent skin and eye contact and breathing of vapor. Wear a properly fitted air-purifying respirator with organic vapor cartridges (NIOSH approved TC-23C), eye protection, gloves and protective clothing. 7. HANDLING AND STORAGE

Precautions for safe handling: Observe label precautions. Keep away from heat, sparks, flame, static discharge and other sources of ignition. VAPORS MAY IGNITE EXPLOSIVELY, Vapors may spread long distances, Prevent buildup of vapors. Extinguish all pilot lights and turn off heaters, non-explosion proof electrical equipment and other sources of ignition during and after use and until all vapors are gone. Close container after each use. Ground containers when pouring. Wash thoroughly after handling and before eating or smoking. Do not store above 49 °C (120 °F).
