4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Procedures for cleaning up spills or leaks: Ventilate area. Remove sources of ignition. Prevent skin and eye contact and breathing of vapor. If the material contains, or is mixed with an isocyanate activator/hardener: Wear a positive-pressure, supplied-air respirator (NIOSH approved TC-19C), eye protection, gloves and protective clothing. Pour liquid decontamination solution over the spill and allow to sit at least 10 minutes. 7. HANDLING AND STORAGE

or smoking. Do not store above 49 °C (120 °F). If material is a coating: do not sand, flame cut, braze or weld dry coating without a NIOSH approved air purifying respirator with particulate filters or appropriate ventilation, and gloves.
